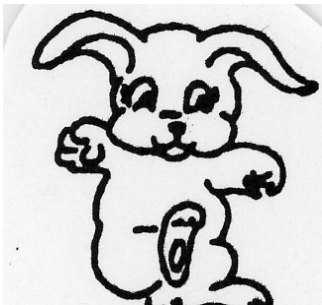

Rabbit & Cavy Entry Information

Entry fee **\$3.00** per class, **\$5.75** two shows, **\$8.50** three shows, **\$11.00** four shows per animal, Fur **\$2.00** per show per animal, postmarked and paid by March 6th.

Late entries/payments received until March 9th are \$4.00 each, after which entries will be considered day of show entries at **\$5.00 each**. **No animal will be judged without prepayment**. **E-mail entries** must be paid by PayPal or check/money order postmarked by **March 9th**.

SHOW RULES

1. This is an official ARBA sanctioned show and will be governed by the latest ARBA show rules. Entry implies acceptance of said rules.
2. All sale animals must meet minimum show weight for breed.
3. NO CHANGES of the paperwork will be made at the judging table without clearance by the show secretary.
4. The American Rabbit Breeders Association host club reserves the right to refuse entries from all locations within 150 miles which has had a confirmed outbreak of RCD/RHD/VHD within the past 60 days of the entry deadline.
5. ARBA or software entry forms are acceptable. Entries MUST BE legible and complete. Collect calls will be made to all exhibitors with incomplete or illegible entry information.
6. Animals are entered at the sole risk and responsibility of the owner.
7. Exhibitors are responsible for getting their own animals to the show table. Exceptions will be made for those assisting with the shows. Classes will not be re-judged.
8. PCRCBA and the Coos County Fairgrounds will not be responsible for accidents, losses or damages that may occur to exhibitors, personal property or stock..
9. Smoking is not allowed in any fairgrounds building and only in designated smoking areas. Alcohol is not permitted.
10. Animals showing signs of (or disqualified for) a communicable disease or parasite MUST be immediately removed from the showroom.
11. Parking will be in designated areas only.
12. No animals will be allowed in the showroom other than rabbits or certified assistance animals.
13. Children are welcome to attend. Parents will be held responsible for any damages to the fairgrounds property or equipment caused by their children.
14. Entries not paid in full prior to each show will not be judged. Exhibitors are responsible for payment regardless of scratches, no shows, etc.
15. All carriers must have leak proof bottoms.
16. All rabbits must be LEGIBLY, permanently, tattooed in the left ear.

OLRCB RULES: Any person with a returned unpaid check (NSF) for this show, for any service, will have their name and the amount of the check submitted to the Oregon League of Rabbit and Cavy Breeders for the express purpose of passing the information to other affiliated clubs in our show area.
