DIRECTIONS FROM KARCHER MALL:

The American Legion is at 126 N Bruneau Hwy, Marsing, ID if you want to find directions from your location you can go to www.mapquest.com to get the exact location from your home.

When you leave the I-84 Freeway at the new exit it will say “Marsing Exit”. Go straight thru the light at Karcher Mall crossing the Nampa Caldwell Blvd and continue straight on Hwy 55 approximately 13.7 miles and you will cross the Snake River and enter Marsing. Slow down, stay in the right lane, go 1 block after crossing the bridge. Turn RIGHT on N Bruneau Hwy, then 1 block to the American Legion Hall. There is lots of parking.

SHOW RULES

1. All ARBA classes may be entered and shown.
2. The show management will eliminate and bar from the show any animals not ear marked properly, not in good health or showing signs of illness.
3. Clubs reserve the right to refuse any entry.
4. There is to be no interference with the judge's placement of any animal, no talking across the table to the judge by the exhibitor, unless the judge so directs. If there is any interference, the exhibitor shall be asked to leave and shall forfeit their entry fees.
5. Each exhibitor is responsible for getting their own animals to and from the show table promptly. Youth exhibitors are required to carry their own animals to the table, unless participating in youth contests, at which time they will be responsible to see that another exhibitor or parent gets their animals to and from the show table.
6. This is a one day, solid bottom carry cage show.
7. SRRCC or show facilitators will not be held responsible for loss due to fire, theft, accident or destruction. All precautions, within reason will be taken.
8. SRRCC reserve the right to substitute judges, to interpret and enforce these and all ARBA show rules.
9. By filling out and signing the entry form, the exhibitor agrees to abide by these show rules and all ARBA rules.
10. Each exhibitor who sends telephone and/or email entries must verify their entries prior to the show starting.
11. No dogs or other animals will be allowed in the showroom without show committee approval.
